The cost of said additional treatment will be paid by the purchaser.
- 2. ENTIRE AGREEMENT. The plan constitutes the entire agreement between the parties and no other representation or statements wil be binding upon parties.
- 3. NOTICE OF CLAIMS, ACCESS TO PROPERTY. Any claim for breach of this agreement will be made immediately in writing to any Sovereign Pest Control office.
